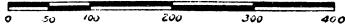
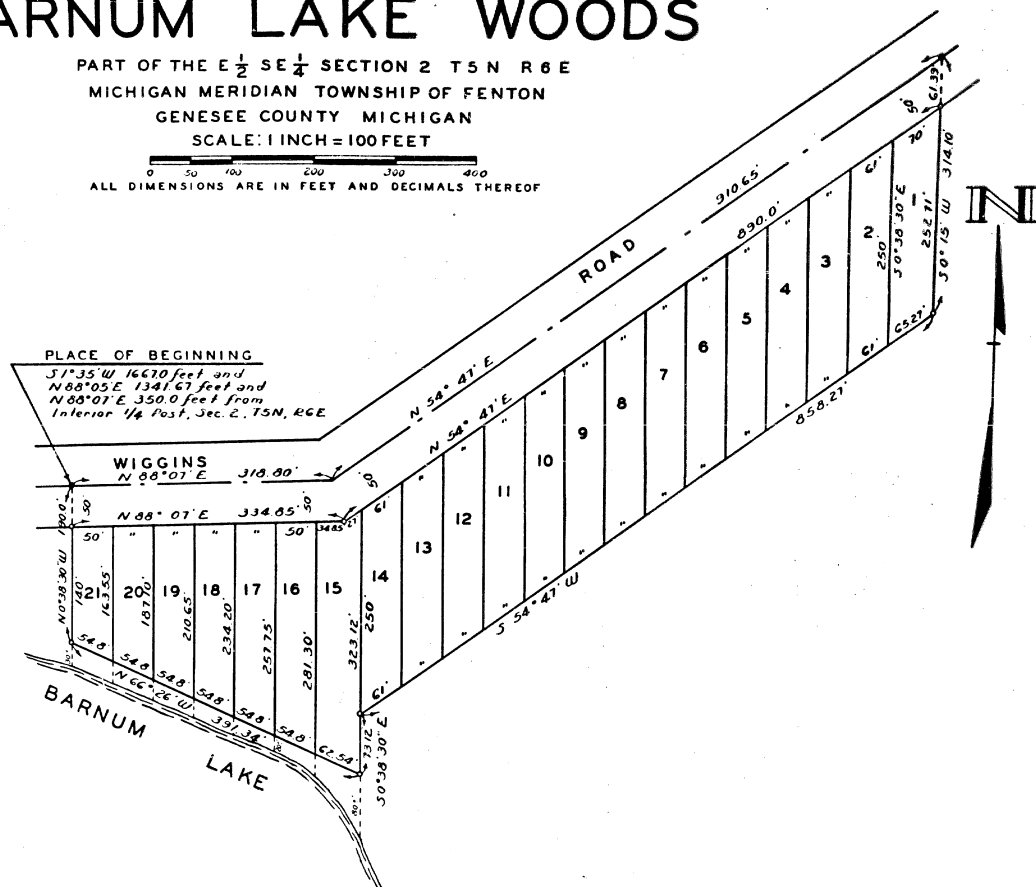


BARNUM LAKE WOODS

DESCRIPTION OF LAND PLATTED

The land embraced in the annexed plat of "BARNUM LAKE WOODS" Part of the E 1/2 SE 1/4 Section 2 T5N R6E Michigan Meridian, Township of Fenton, Genesee County, Michigan is described as follows: Beginning at a point in the centerline of Wiggins Road, so-called, S. 1° 35' W. 1667.0 feet, and N. 88° 05' E. 1341.67 feet, and N. 88° 07' E. 350.0 feet from the interior quarter Post of said Section 2, thence N. 88° 07' E. 318.80 feet, thence N. 54° 41' E. 910.65 feet, thence S. 0° 15' W. 311.10 feet, thence S. 54° 41' W. 858.27 feet, thence S. 0° 38' 30" E. 73.12 feet, thence N. 68° 26' W. 391.34 feet, thence N. 0° 38' 30" W. 190 feet to the place of beginning. Lots 15 to 21 inclusive include the land to the low water mark of Barnum Lake between the side lot lines extended.
