## NOTICE OF RESOLUTION

At a meeting of The Board of County Road Commissioners of the County of Genesee, Michigan, held at 211 West Oakley Street, Flint, Michigan, on the 18th day of July 19th Alp., at which time a quorum of the members was present, the following resolution was unanimously adopted by vote taken by yeas and nays and entered at large upon the records of said Board.

## RESOLUTION

WHEREAS, we, as said Board, are in receipt of a written petition signed by certain freeholders of the Township of Fenton, Genesee County, Michigan, praying for the absolute abandonment and discontinuance of a portion of street; and,

WHEREAS, the portion of street is described as follows: All that portion of MOFFETT DRIVE being 60 feet in width and extending N'ly from the south plat line of Dawson Plat to a line lying 54.09 feet N'ly of and parallel to the aforementioned south line of Dawson Plat, as shown in the recorded plat of Dawson Plat (Liber 22, page 44). Section 24, Fenton Township, Genesee County, Michigan. Said segment of street is adjacent to lot 1 on the West and lot 64 on the East of the aforesaid nlat: and.

WHEREAS, a public hearing was held at 10:30 a.m., December 18, 1984, at 211 West Oakley Street, Flint, Michigan, to hear objections to this proposed abandonment and discontinuance; and,

WHEREAS, there were no objections heard to the absolute abandonment and discontinuance of this portion of street; and,

WHEREAS, it is the belief of the Board that the best interests of the public will be served by the absolute abandonment and discontinuance of this portion of street and at this time a more valuable use of the property is possible.

NOW, THEREFORE, BE IT RESOLVED, That in the best interests of the public welfare, the portion of street hereinbefore described be and the same is hereby absolutely abandoned and discontinued as a public street, subject to the reservation of an easement for public utility purposes within the right-of-way of said portion of street as provided under section 257 of Act No. 288 of Michigan Public Acts of 1967 and the same be placed on the assessment rolls forthe purpose of taxation.

BE IT FURTHER RESOLVED, That a notice of this determination be published in The Flint-Genesee County Legal News, a newspaper of general circulation in Genesee County, once each week for three consecutive weeks; that certified copies of this resolution be served on the Michigan Department of Transportation, the Auditor General of the State of Michigan, and the Clerk of Fenton Township; that Consumers Power Company, Michigan Bell Telephone Company and the U. S. Postal Service be notified of this abandonment by letter; and that a copy of this resolution be recorded in the office of the Register of Deeds for the County of Genesee, Michigan.
