## **2002 Local Road Improvement Projects**

Michele Spear, 3194 Ponemah Drive

Ms. Spear asked if the residents of Ponemah Drive would have to pay any of the cost of the road repairs. Supervisor Gabrielson confirmed that the residents would not be asked to absorb any of the cost of the repairs.

In addition to the Ponemah Drive project, Supervisor Gabrielson and the board discussed several other potential local road improvement projects:

- 1. Hogan Road (Lahring Road to Ray Road) limestone resurfacing
- 2. Lobdell Road (Linden Road to Whitaker Road) limestone resurfacing
- 3. Sharp Road (Lahring Road to Ray Road)—limestone resurfacing
- 4. Rolston Road (Hogan Road to Linden City limits) limestone resurfacing
- 5. Whitaker Road (Lobdell Road north to pavement) limestone resurfacing

The input from this hearing will be used to gather cost estimates for potential projects. After a comparison to budget, recommendations will be brought back to the next meeting.

## Amendment to Open Burning Regulation Ordinance/1st Reading

Supervisor Gabrielson reviewed a proposed amendment to the Open Burning Regulation Ordinance. The amendment would reduce the minimum land area for issuance of a burning permit from 15 acres to 10 acres. The additional requirement that the land must be used for agricultural purposes will remain in the ordinance. Fire Chief Moulton has reviewed the issue and has indicated support for this amendment. Clerk Mueller stated

that the original language was intended to limit the issuance of burning permits. Experience has shown, however, that the current ordinance unfairly restricts land-clearing efforts of legitimate agricultural operations. There was no public comment. The second reading of the proposed amendatory ordinance will be conducted at the 1/21/02 meeting.

# <u>Proposed Amendment to Ordinance No. 461 – Group Medical Insurance/1st Reading</u>

Supervisor Gabrielson briefly reviewed the proposed amendment to the Group Medical Insurance ordinance. The amendment changes the language in the eligibility section from "All Township Fire Chiefs" to "The Township Fire Chief". There was no public comment. The second reading of the proposed amendatory ordinance will be conducted at the 1/21/02 meeting.

## Proposed Amendment to Ordinance No. 462 – Group Life Insurance/1st Reading

Supervisor Gabrielson briefly reviewed the proposed amendment to the Group Life Insurance ordinance. The amendment changes the language in the eligibility section from "All Township Fire Chiefs" to "The Township Fire Chief". There was no public comment. ## Request for Industrial Development District – Contour Fabricators, Inc.

Creation of the district would then allow them to apply for an Industrial Facilities Exemption Certificate (i.e. tax abatement) for a planned expansion of their current facility. A public hearing is necessary before making a decision on the establishment of the Industrial Development District.

Motion to schedule a public hearing to consider the request of Contour Fabricators Inc. to establish parcel 06-24-100-010 as an Industrial Development District, in accordance with PA 198 of 1974, as amended.

## **Employment of Co-op Student / Spring 2002 Semester**

Fenton High School senior Shelby Brayton will be completing her co-op semester on January 11<sup>th</sup>. Shelby has done an outstanding job for the township over the past several months. Lake Fenton High School senior Megan Reynolds has expressed an interest in working at the Fenton Township office this semester as a co-op student. If approved, the student/employee would work 15-20 hours per week and rotate among various jobs in the office, work on special projects and be trained to provide backup to key positions.

## **Purchase of GPS Equipment**

Supervisor Gabrielson asked the board to review the recently approved contract with North Arrow Technologies for GIS services. North Arrow has asked for an interpretation of the section of the contract that obligates the township to provide computer equipment for the project. The issue is whether the township or the contractor is responsible to provide the Global Positioning System (GPS) equipment necessary to complete the project. Trustee Rowe stated that the GPS equipment should fall under the category of "workman's tools" and should be the responsibility of the contractor. After a brief discussion the board agreed with this position. No further board action is necessary.
