

PUBLIC NOTICE
CHARTER TOWNSHIP OF FENTON
BOARD MEETING SYNOPSIS
JUNE 5, 2006

The Fenton Township Board held a regular meeting on Monday June 5, 2006 at the Fenton Township Civic Community Center, 12060 Mantawauka Drive, Fenton, Michigan and took the following actions.

1. Supervisor Mathis led the pledge of allegiance to the flag.
2. Approved the agenda as presented.
3. Approved invoices for payment.
4. Conducted a public hearing and first reading of a proposed Zoning Ordinance amendment to revise the legal description on a previously approved PUD rezoning for parcels 06-27-100-004 & 06-27-100-015, (3472 Allen's Landing).
5. Conducted a public hearing and first reading of a proposed Zoning Ordinance amendment to revise conditions of a previously approved PUD rezoning for parcels 06-13-100-007 & 06-12-300-013, (east side of Fenton Road across from Log Cabin Point).
6. Conducted a public hearing and first reading of a proposed Zoning Ordinance amendment to rezone parcels 06-03-300-003 & 06-10-100-018, (south side of Thompson Road east of Jennings Road), from AG and/or RMH, R-3 and C-3 to PUD.
7. Adopted Resolution No. 2006-12, requesting a DNR public hearing on the necessity for a no-wake ordinance on McCully Lake.
8. Adopted Resolution No. 2006-13, honoring former Township Trustee and Planning Commissioner Calvin C. Gatesman for his years of service to Fenton Township.
9. Adopted Resolution No. 2006-14, supporting the application of the Genesee County Road Commission for replacement of the Hogan Road Bridge over the Shiawassee River under the MDOT Local Bridge Program, and to commit funding for the Township's share of the project in 2009, if the application is approved.
10. Granted a one year extension for the final approval of the Preliminary Plat of Byram Ridge.
11. Appointed John R. Tucker to the position of Township Trustee to fill the unexpired term ending 11/20/08.
12. Appointed John R. Tucker as the Township Board representative on the Fenton Township Planning Commission.
13. Re-appointed Martin K. Spees to the Fenton Township Planning Commission for the term ending 5/31/09.
14. Re-appointed James V. Root to the Fenton Township Planning Commission for the term ending 5/31/09.
15. Appointed Thomas J. Richard to the Fenton Township Planning Commission for the term ending 5/31/09.
16. Adjourned at 9:20 p.m.
