PRESENTATION:

GIS Overview - North Arrow Technologies, Inc.

Supervisor Mathis introduced Jeff Lewis of North Arrow Technologies, the Township's Geographic Information System (GIS) consultant. Mr. Lewis gave a brief history of the Township's GIS, which began in 2001. The GIS has developed into a multi-faceted tool that provides valuable information to all Township departments. Mr. Lewis also highlighted some of the significant benefits of the GIS, such as integration with the Township's website, property assessment information interface, the GPS location of all sewer manholes and pump stations, mapping for the Fire Department, and the ability to quickly identify property owners for legal notifications. Trustee Hill stated that he is very impressed with the work done by North Arrow Technologies. He was not previously aware of the extent that the GIS is used by the Township. The board thanked Mr. Lewis for his very informative presentation.

Property Values & Taxes – Treasurer Tucker

Treasurer Tucker reviewed property value information obtained from Genesee County. Many property owners will face the situation this year where the value of their property has decreased but their taxable value has increased. He showed the historical impact of Proposal A, passed in 1994, on a typical property. A home with a true cash value of \$60,000 in 1993 has saved approximately \$20,000 in property taxes since the implementation of Proposal A. While the current situation may result in a tax increase for some, they have still benefited from the initial tax cut and the lower-than-market increases to their taxable value since Proposal A. There have been movements to change the law so taxable values cannot increase if the equalized value decreases. So far no new laws have been passed. While it is not likely to make property owners any happier, Mr. Tucker hopes this information can be used to help them better understand the situation. The board thanked Treasurer Tucker for this very useful information.

Road Weight Restrictions

Supervisor Mathis reported that the Genesee County Road Commission implemented seasonal weight restrictions for all roads beginning 2/13/09. These restrictions will remain in effect indefinitely, and will likely be lifted in April or May.

Supervisor Mathis reported that a Fenton Township resident, Tom Callahan, was instrumental in the rescue of a woman and her baby from the Silver Lake Apartment fire last week. We will gather more information and prepare a resolution to honor our local heroes. She also noted that donations are collected to help those people affected by this fire.

PUBLIC COMMENT - AGENDA OR NON-AGENDA ITEMS:

Ed Collins, 13056 Harbor Landings Drive

Regarding the CDBG inter-local loan agreement approved at the last meeting, Mr. Collins asked what was the total amount of funds allocated to Fenton Township. Operations Manager Broecker stated that the total allocation was approximately \$110,000. 15% was allocated to Loose Senior Center operations and approximately \$5,800 was allocated to a road improvement project on a direct benefit basis.

Susan Foland, 11421 Fairbanks Road

Regarding the upcoming bond issue, Ms. Foland asked what interest rate would apply to those bonds. Operations Manager Broecker clarified that the interest rate will be determined at the time of sale, which is a competitive process. Ms. Foland also asked if

the proceeds from the sale of bonds will be used to purchase additional equipment such as generators. Operations Manager Broecker stated that capital equipment purchases are an appropriate use for bond proceeds, although that decision has not been made.

Ray Dillard, 13331 Crane Ridge Drive

Mr. Dillard stated that he is concerned about the very poor condition of Crane Road and the collapsed drainage culvert that connects Golden Pond with Lake Fenton. Supervisor Mathis stated that she has already been in contact with the Genesee County Road Commission and they will be patching the road tomorrow (2/17/09). The culvert will likely take more time to replace, however that area will also be patched to make it passable.

Regarding a question from a previous meeting posed by Susan Foland, Clerk Krug reported that the sewer emergency costs related to the heavy rains and melting snow on 12/27/08 totaled \$17,288.80.
