## **Selection of CDBG Projects**

Operations Manager Broecker reviewed several recommendations for Community Development Block Grant (CDBG) projects. After lengthy discussion, the following projects were recommended for application:

### 1. Home Safety Items for Senior Citizens (public service project)

The purchase of home safety items for senior citizens, (smoke detectors, carbon monoxide detectors, deadbolt locks, etc.). Recommended funding: half of the 15% allocated to public service projects (approximately \$6,300).

## 2. <u>Subsidize child care for newly employed, low-income individuals (public service project)</u>

The structure of this project is yet to be determined since it has not been attempted previously in Genesee County. Recommended funding: half of the 15% allocated to public service projects (approximately \$6,300).

## 3. <u>Street Improvements – Alpine Shores Subdivision (Direct Benefit)</u>

The Alpine Shores subdivision has requested special assessment petitions to have their streets re-paved. If approved, these funds could be used to pay off the special assessments for those residents who are eligible under the HUD low-moderate income requirements. Recommended funding: \$20,000.

## 4. Generator – Fenton Township Civic Community Center

The Fenton Township Civic Community Center is the designated storm shelter for residents of the Lake Fenton Mobile Home Park. Subject to an income survey, that should make the purchase of a permanently installed generator at the township hall an eligible project. Recommended funding: \$80,000.

5. <u>ADA Improvements – Fenton Township Civic Community Center Parking Lot</u> The parking lot at the township hall needs additional handicapped parking spaces in order to be in compliance with current regulations. Recommended funding: \$31,000.

That leaves approximately \$20,000 available for other projects. Some of the other projects discussed for which all information has not been received:

- Subsidization of Southern Lakes Parks & Recreation scholarship program.
- Barrier-free/ADA upgrades to Township Hall restrooms.

These projects may be brought back to the 12/7/09 meeting for additional approval.

WHEREAS, the Charter Township of Fenton has a need to pay to the County of Genesee the sum of \$2,034,546.30 to meet the bond principal and interest requirements on all bond obligations for sewer facilities in 2010; and

WHEREAS, there are several means by which the funds can be secured to meet this payment requirement; and

WHEREAS, all various means of securing these funds have been reviewed and considered;

NOW THEREFORE BE IT RESOLVED, by the Charter Township of Fenton, that the monies to meet the principal and interest requirements on all bond obligations for sewer facilities in 2010 will be secured from the following funds.

Trustee Goupil, who is also a Genesee County Sheriff Department Paramedic, agreed with Clerk Krug. Having more than one ambulance company providing service in the community creates competition and improves the overall service being provided.
