ADOPTION OF ORDINANCES:

Proposed Medical Marihuana Ordinance/2nd Reading

Supervisor Mathis acknowledged that this proposed ordinance was postponed at the last meeting in order to research issues raised at that meeting. At a workshop meeting

earlier this evening the board discussed the proposed ordinance with the township's Zoning Administrator.

Public Comment:

Carrie Justice, Linden, MI

Ms. Justice urged the board to reconsider the proposed ordinance – it is more restrictive that the state law. It is her understanding that the ACLU has already received a complaint about the ordinance and it will likely end up in court, which will cost our taxpayers money. Ms. Justice indicated that some of the restrictions may constitute a violation of the Michigan Right to Farm Act. She also restated many of the concerns raised at the last meeting, including:

Section 6D

 This section is unduly restrictive. Proximity to a school or church is not relevant if growing/cultivating location is properly secured as required by the proposed ordinance.

Section 6F

• One of the responsibilities of a primary caregiver is to give instruction to a patient on the various methods to use medical marihuana. This section would prohibit such instruction from occurring at the primary caregiver's location.

Sections 6G & 6H

- These sections are a violation of HIPPA regulations.
- Would this information be subject to disclosure under FOIA?
- Enforcing these sections would create a "list" of primary caregivers that would make them targets of thieves and illegal drug users.
- These sections are an unwarranted invasion of privacy.

Clerk Krug pointed out that the proposed ordinance does not require any information regarding patients. Therefore it would not be a violation of any HIPPA regulations.

Mike Collins, Fenton, MI

Mr. Collins stated that the Township is overstepping its authority with this ordinance. The board should be more concerned about the rights of its citizens that promoting commercial enterprises.

Clerk Krug stated that Senate Bill 618, which would consolidate the production of medical marihuana and require dispensation through pharmacies, would resolve the issues regarding this ordinance.

Treasurer Tucker stated that he prefers to adopt the ordinance as is, with the understanding that it would be immediately referred back to the Planning Commission for review and revision. Trustee Brown stated that he would prefer to revise the ordinance before adoption.

Motion to adopt Ordinance No. 720, a Medical Marihuana Ordinance, as presented.

Proposed Amendment to Disorderly Persons Ordinance/1st Reading

Supervisor Mathis reviewed a proposed amendment to the Township's Disorderly Persons Ordinance. The amendment would add illegal possession of marihuana and public consumption of marihuana as violations. Attorney Cooley explained that this would give another option to law enforcement officers for minor violations.

There was no public comment. The second reading of the proposed ordinance amendment will be conducted at the 3/29/10 meeting.

Supervisor Mathis reminded the board and audience that the next regular township board meeting will be Monday 3/29/10.

NEW BUSINESS:

Proposed Goose Population Reduction - Silver & Marl Lakes

Supervisor Mathis stated that the Township has again received a request for formal support for goose control efforts on Silver and Marl Lakes. Unlike past years where the geese were rounded up and relocated, the new program involves destruction of nests and eggs and possible the capture of geese for food processing. The Silver-Marl Lake Association has requested a letter of support that would be effective for five years. Supervisor Mathis prefers addressing the issue each year.

Motion to support the request of the Silver-Marl Lake Association for goose population reduction measures for 2010 only, as requested.

Resolution No. 2010-10, supporting Argentine Township's Parks & Rec Plan

Supervisor Mathis reported that Argentine Township is in the process of updating is Parks & Recreation Plan, including non-motorized walkways. The board has been provided a copy of the plan and is being requested to adopt a resolution of support. Victor Lukasavitz of Gould Engineering stated that the proposed plan is very supportive of walkways, walkable communities and other "green" approaches. Both the City of Linden and the Genesee County Metropolitan Planning Commission have adopted similar resolutions of support.

Clerk Krug presented the following resolution:

WHEREAS the Charter Township of Fenton encourages joint governmental cooperation with the City of Fenton, City of Linden, and Argentine Township through joint community and infrastructure planning because it connects adjoining community attributes with school facilities, regional features and programs, and Genesee County Parks; and

WHEREAS creating intercommunity connections through multi-use pathways and complete streets coincides with the Charter Township of Fenton's long term planning goals and objectives to create a safe, pedestrian-friendly environment that will encourage residents to walk, bicycle, and interact with other communities without worry; and

WHEREAS multi-use pathways proposed in Argentine Township's 2010-2014 Parks & Recreation Plan will provide opportunity for Fenton Township citizens and those of adjoining communities to improve their physical health and contribute to a greener environment; and

WHEREAS working together to support the efforts of adjoining communities to promote smart commute and alternate forms of transportation will create strategic growth, environmental integrity, economic prosperity, and social equality making all the communities in southern Genesee County great places to work, live and play.

NOW, THEREFORE, BE IT RESOLVED that the Fenton Township Board of Trustees hereby declares its support for Argentine Township's 2010-2014 Parks & Recreation Plan.
