NEW BUSINESS PUBLIC HEARINGS:

SUP11-001 Adopt-a-Pet, 13575 Fenton Rd.:

06-13-300-001.

Request: amend their Special Use Permit to build an addition to the existing facility.

Secretary McGuirk reviewed file. Jody Maddock, Director of Adopt-a-Pet, sworn in and explained the proposed 28 ft. x 40 ft. addition will have heated floors and a new ventilation system and a basement to offer a way to keep sick animals away from the general population and also to provide an area for the low cost spay and neuter program. Maddock noted that the existing SUP allows for 15 dogs with 4 adult dog runs, she further explained Adopt-a-Pet has a large presence in the community and have added a 300% increase to the volunteer base with many of the volunteers neighbors who foster dogs. Chairperson Pro-Tem Carlson called for audience comment, there was none. Secretary McGuirk noted there were 13 letters in the file all in support of request, none in opposition. Franz questioned the appearance of the proposed addition, Mark Maddock explained the addition will have the same exterior finishes and siding as existing. Carlson questioned how the proposed addition will benefit the organization, Maddock stated they will be able to double the amount of adoptions. Franz questioned if the addition will be in the area of the existing animal pen, Maddock said it will decrease the existing pen by ½ however they will add a second 20 ft. x 50 ft. outdoor pen. Franz questioned who will be constructing the addition, Maddock explained it will mainly be volunteers. Richard noted it appears the addition will cause some lose of parking, Maddock stated they will loose 5 spaces however they will bring in additional base to add new spaces. Lorraine commented this program is a great asset to the community. Kathleen Fox 1368 Petts Rd. guestioned if they have always been allowed to have dogs on this site and noted she did move to this area for the quiet and on occasion the dogs bark and disturb her peace. Maddock stated if this is an issue they can plant evergreens along the property line. Maddock then asked if it was possible to have Saturday hours at the site. Carlson explained they would not be able to add Saturday hours at this meeting because that is an additional condition to the SUP and would need to be advertised however the Planning Commission can vote on what is before them and postpone the meeting until next month to hear a request for hours of operation on Saturdays.
