2023 MARCH BOARD OF REVIEW



What is the Board of Review?

The March Board of Review meets each year to hold scheduled appeal hearings following the required organizational meeting. The appeal hearings will be held at the Township Hall.

The March Board of Review consists of one Chairman and two members with 2/3rds of the board being taxpayers of the Township.

The duties of the March Board of Review are to hear and make decisions based upon support provided by and on the taxpayer's request.

The March Board of Review has the authority to review the following types of appeals: Current year assessed and taxable values; current year poverty exemptions under MCL 211.7u; current year assessor denial of Agricultural exemptions and current year assessment classifications.

If a taxpayer intends on appealing, please call the assessor's office to schedule an appointment with the March Board of Review at 810-629-3445.

Deadline to file is February 20, 2023 with the local assessor.

CHANGES: Small Business Tax Payer Exemption threshold has been increased from \$80,000 to \$180,000. The filing on the Exemption form has changed for those who qualify please visit our website for the forms and Instructions to ensure proper filing.

Public Act 150 of 2021 was signed by the Governor on December 23, 2021. The Act amends the Small Business Taxpayer Personal Property Tax Exemption (MCL 211.90) to increase the combined true cash value limit for "eligible personal property" in a local unit from \$80,000 to \$180,000 beginning in 2023. The exemption is required to be claimed with the local unit (city or township where the property is located) by February 21, 2023 (postmark is acceptable) by submitting the completed Form 5076 Small Business Property Tax Exemption Claim Under MCL 211.90. Late filed forms may be filed directly with the 2023 March Board of Review prior to the closure of the March Board.

The inflation rate, expressed as a multiplier, to be used in the 2023 Capped Value Formula is 1.05 (5%) for 2023
