A note from Republic Services regarding yard waste collection.

For 2022 yard waste collection is slated to go thru the end of November. With Thanksgiving falling right before the final collection of the month please note that the final yard waste collection will take place on Saturday, November 26.

The unofficial results from the general election indicate passage of the Fenton Township Collection Assessment Trash renewal (7,238 Yes; 2,144 No) which will include for 2023 an extension of yard waste collection from April - December.
